General Visitor Information

Perimeter Security:

All visitor and commercial vehicles will be inspected. Visitors must show one (1) form of identification (a government-issued photo ID — driver's license, passport, green card, etc.).

All shuttle buses from off-campus facilities will undergo inspection at the campus perimeter, but will be allowed to enter and circulate on campus once inspected.

All visitor vehicles, including taxicabs, hotel and airport shuttles, delivery trucks and vans will be inspected before being allowed on campus. Visitors will be asked to show one (1) form of personal identification and to state the purpose of their visit. Be sure to allow extra time for this vehicle inspection procedure.

Please be aware: Federal law prohibits the following items on Federal property: firearms, explosives, archery equipment, dangerous weapons, knives with blades over 2 ½ inches, alcoholic beverages and open containers of alcohol. Also, effective October 1, 2008, the use of all tobacco products (including cigarettes, cigars, pipes, smokeless tobacco, or other tobacco products) is prohibited at all times: In all buildings; On all outside property or grounds, including parking areas; In government vehicles.

Entering Campus:

BY CAR:

Between 6am and 6pm – All visitors arriving in vehicles, on motorcycles or bicycles must go through the NIH Gateway Vehicle Inspection Station (unless they already have an NIH badge or an extended-visitor pass). Enter the Gateway Center complex through NIH Gateway Drive, just south of the intersection of the South Drive and Rockville Pike/Wisconsin Ave.

Before 6am and after 6pm – All visitors must enter campus through the Commercial Vehicle Inspection Facility (CVIF). Open 24 Hours. Enter the CVIF via Rockville Pike south of North Drive.

Visitors will be asked to submit to a vehicle or personal inspection. Visitors over 15 years of age must provide a form of government-issued ID. Visitors under 16 years of age must be accompanied by an adult.

Once on campus, stay on Center Drive until you reach the Clinical Center - Building 10 on the left.

PARKING:

To Valet Park, make a U-Turn to enter the one-way Main Entrance. Valet parking is available Monday through Friday, 7am -10pm (excluding federal holidays). See the Hospitality desk for valet claim ticket validation.

To Self Park, continue around the Clinical Center; look for "Patient Parking" sign on left. Continue under the building to the Patient Parking garage located on P1, which is on the west end of the building on Convent Drive. Parking attendants will be available for assistance. To validate the parking ticket, stop by the P1 parking hospitality desk. The South Elevators serve the parking garages.

Another entrance (for volunteers with an extended visitor pass) is open Monday - Friday, 7am - 7pm

Healthy volunteers, patients, and patient visitors may use this entrance at the intersection of West Cedar Lane and West Drive, directly north of the main entrance of the Mark O. Hatfield Clinical Research Center. This entrance also requires presentation of a valid photo ID if you are 16 or older.

This gate is for **entry only** (except in emergencies) and will be closed weekends and holidays. To leave NIH, follow signs to any of the other gates.

BY METRORAIL:

Take the RED LINE to the Medical Center Stop. Please exit up the escalator and enter directly into the NIH Gateway Visitor Center Building. Visitors will be asked to show one (1) form of identification (a government-issued photo ID — driver's license, passport, green card, etc.) Once issued a visitor badge, there are two (2) options to get to the Hatfield Building (Building 10) Clinical Center. - Take NIH Campus Shuttle bus that stops at the Metro Station every ten minutes
- Walk (~10 minutes). Travel down South Drive, following signs to Bldg 10. Enter Clinical Center through South Entry. Metrorail service is available from Washington's National Airport and from Union Station (railway).

Patients and Healthy Volunteers who are NEW to the Clinical Center:

All patients and healthy volunteers must go to the **ADMISSIONS** department on the 1st floor of Building 10 before their first clinic appointment at the NIH Clinical Center to receive a **MEDICAL RECORD** number.

TO GET TO NIH MEDICAL ADMISSIONS on the 1st Floor of the Clinical Center:

Follow the signs to **ADMISSIONS** located to the west side of the hall behind the fish tank.

- **From the P1 LEVEL PATIENT PARKING:** Go up one level to the 1st floor.
- **From the MAIN ENTRANCE (Valet Parking or Shuttle Drop Off):** Go straight down the atrium, past the central elevators.
- **From the SOUTH ENTRANCE:** Continue down the long hallway towards ADMISSIONS (follow the signs overhead). You will pass the MAIN ELEVATORS.

Directions to the new VRC Clinic location at the Vaccine Evaluation Clinic (5th Floor, NE-S):

After finishing with the Admissions process, **please wait** until receiving the **MEDICAL RECORD** and then proceed to the Vaccine Research Center clinic located in the Vaccine Evaluation Clinic on the 5th floor, NES. Go to the **CENTRAL ELEVATORS**, indicated in **BLUE** (on the floor-plan on Page 6). Take the elevator to the 5th floor. Upon exiting the elevator, head to the right (northeast) around the atrium and continue around to the North Elevators. The clinic is located straight past the North Elevators. Look for signs for the VRC Vaccine Evaluation Clinic. Upon entering the clinic, please **sign-in** at the reception area and see a VRC staff member for assistance.

Driving Directions to the Clinical Center (Building 10)

From Baltimore and All Points North of Washington DC:

Take I-95 S toward Washington, DC. At I-495 (Capital Beltway), head west toward Silver Spring/Bethesda. From the Beltway (I-495), take Exit 34 to Rt. 355 (Wisconsin Ave./Rockville Pike) and head south toward Washington/Bethesda. Continue just past the fifth traffic light at South Drive and make a right at NIH Gateway Drive, leading to the Gateway Center complex.

From Virginia and All Points South of Washington DC:

Take I-95 N toward Washington, DC. At I-495 (Capital Beltway), head north toward Silver Spring/Bethesda. From the Beltway (I-495), take Exit 34 to Rt. 355 (Wisconsin Ave./Rockville Pike) and head south toward Washington/Bethesda. Continue just past the fifth traffic light at South Drive and make a right at NIH Gateway Drive, leading to the Gateway Center complex.

From Baltimore-Washington International Airport (BWI):

Take the Baltimore-Washington Parkway S toward Washington, DC. At I-495 (Capital Beltway), head west toward Silver Spring/Bethesda. From the Beltway (I-495), take Exit 34 to Rt. 355 (Wisconsin Ave./Rockville Pike) and head south toward Washington/Bethesda. Continue just past the fifth traffic light at South Drive and make a right at NIH Gateway Drive, leading to the Gateway Center complex.

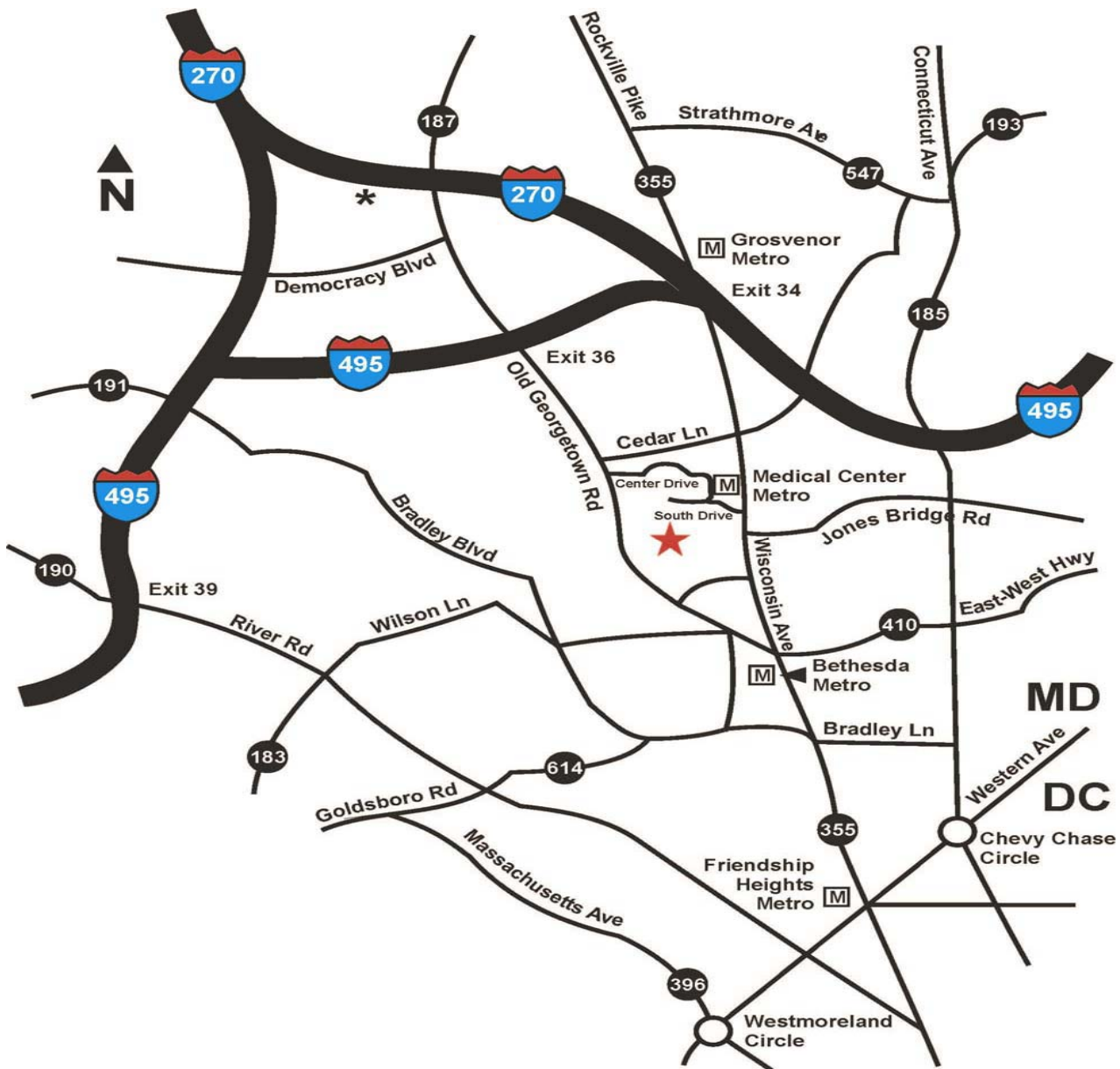
From Dulles International Airport:

Head east on the Dulles Airport Access Road for approximately 13 miles. Exit onto I-495 (Capital Beltway), heading north to Bethesda/Baltimore. From the Beltway (I-495), take Exit 34 to Rt. 355 (Wisconsin Ave./Rockville Pike) and head south toward Washington/Bethesda. Continue just past the fifth traffic light at South Drive and make a right at NIH Gateway Drive, leading to the Gateway Center complex.

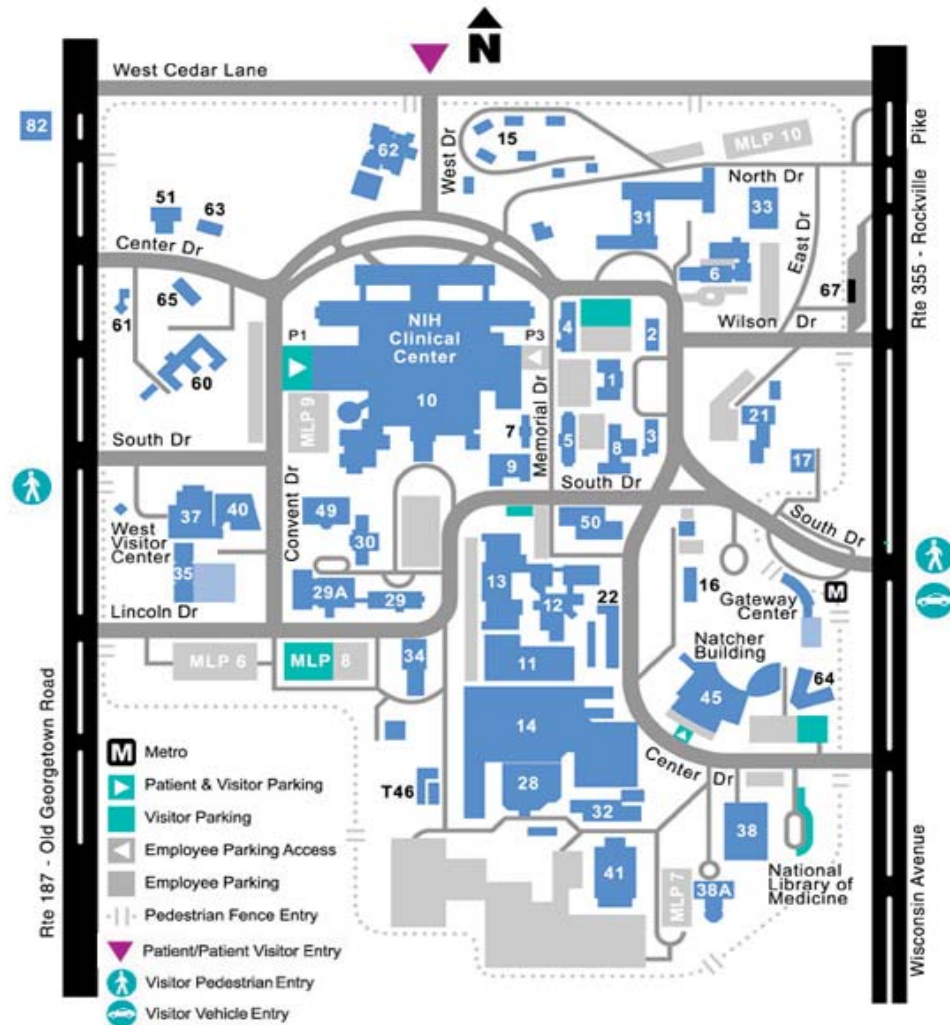
From Ronald Reagan National Airport:

Head north on the George Washington Parkway for approximately 5 miles. Exit onto I-495 (Capital Beltway), heading north to Maryland. From the Beltway (I-495), take Exit 34 to Rt. 355 (Wisconsin Ave./Rockville Pike) and head south toward Washington/Bethesda. Continue just past the fifth traffic light at South Drive. Make a right at NIH Gateway Drive.

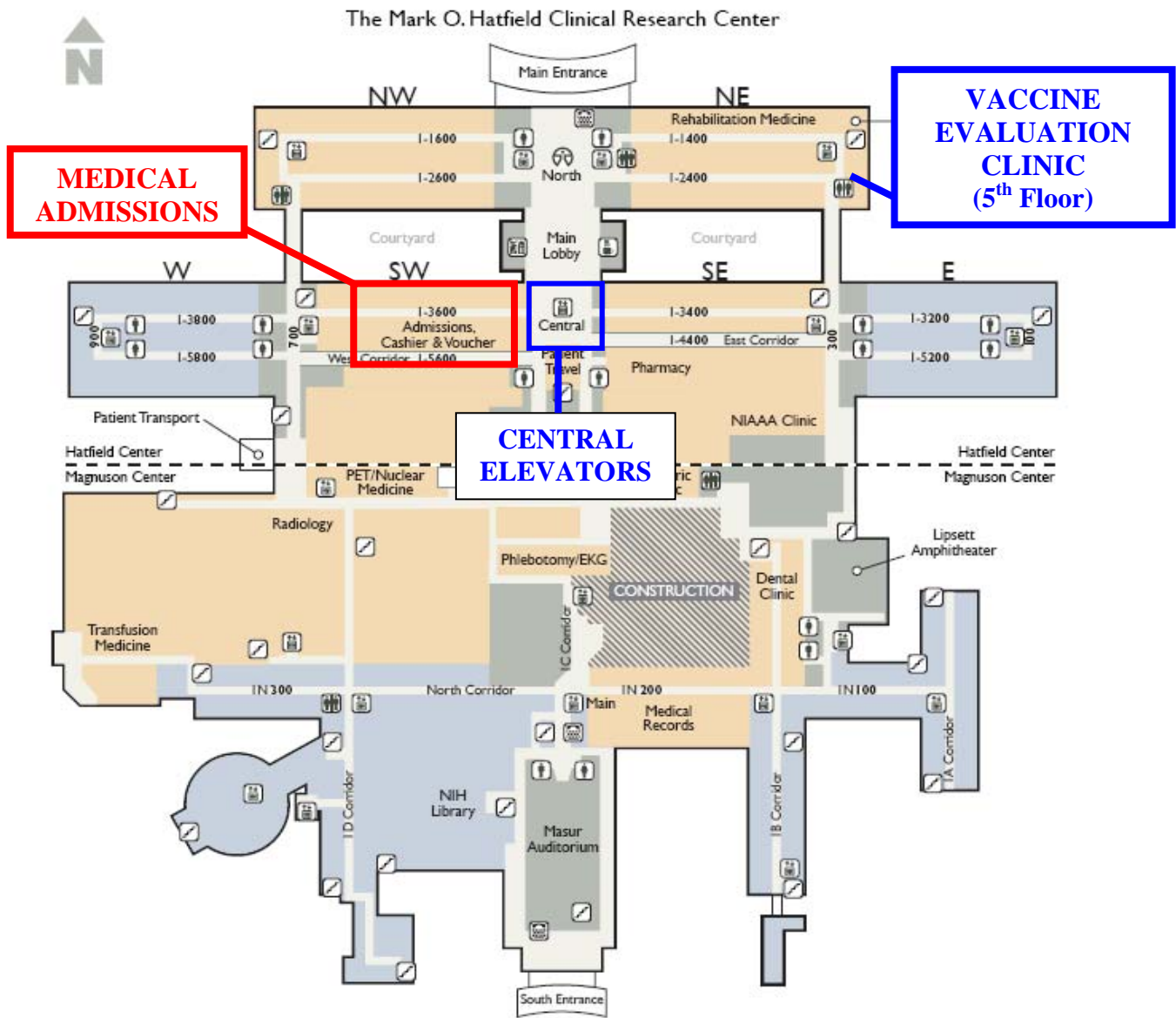
